**\*\* Note: There is a \$30 pull fee required for reserved numbers if applicable. There is an annual additional \$48 fee due the BMV for a Personalized License Plate (PLP). The deadline for you to apply is December 31 for new PLP applications for the following year. Unlike standard issue plates, all PLPs are issued in April. # Indiana Rotary License Plate FAQ's

1. Question: Can I get an Indiana Rotary license plate a special number on it?

Answer: Yes, as long as the digits have not been requested prior to your request. You will be required to pay an additional pull fee to the BMV of \$30.00 because it is a specially requested number.

2. Question: Can I have my initials (*i.e.* ABCD) or personalize my Indiana Rotary License Plate?

Answer: Yes, you can personalize your license plate (PLP) for 2007. You must reserve your plate by December 31, prior to the year of issuance. The BMV charges an additional \$48 fee annually for a PLP. See <http://www.in.gov/bmv/platesandtitles/plp.html> for additional information on PLPs.

3. Question: How many letters can I have on my personalized plate?

Answer: You may select up to **five (5) alphanumeric characters**. Please call your local BMV Office to confirm availability of your desired characters.

4. Question: Can I obtain an Indiana Rotary license plate if I have already renewed with a standard license plate for 2007?

Answer: Yes: However you will need to pay additional fees (around \$8) to exchange license plates.

5. Question: Can I purchase an Indiana Rotary license plate prior to my month of expiration? (*i.e.* John Smith's license plate expires in September, can he purchase his plate in January?)

Answer: Yes. You will simply pay your renewal fees earlier in the year.

6. Question: Do I have to pay the \$40.00 fee each year I renew?

Answer: Yes. You will pay \$25.00 to the Columbus Sunrise Rotary Club (CSRC) and a \$15.00 administrative fee to the Indiana BMV. Note that \$15 of the fee paid to the CSRC will be returned to your club (or the club you designate) for charitable purposes.

7. Question: What types of vehicles use an Indiana Rotary license plate?

Answer: These plates can be used on passenger cars, trucks up to 11,000 lbs., recreational vehicles and motorcycles. They cannot be used on trailers.

8. Question: How can I obtain additional Indiana Rotary license plate applications?

Answer: These are available on the 3 District websites. 9. Question: What happens if Rotary doesn't sell 500 plates each year?

Answer: All Special Groups in Indiana are required to maintain 500 or more sales per year. The Indiana BMV may discontinue the plates if we do not maintain that sales level. With over 8,300 Rotarians across the state of Indiana, we should be able to maintain at least the minimum, however we need your help to first purchase a Indiana Rotary License Plate and then ask everyone in your Club to also Step up to the Plate!
